- 2. Meeting started at 10:15 AM. Homoeopathic Doctor Javed Akhtar recited the verses from the "HOLY QURAN". Homoeopathic Doctor Siddique Ali Ansari offered Nahat Sharif.
- 3. Registrar, Mr. Aamir Nadeem Ramay welcomed all the newly elected and nominated Members of the Council on behalf of the staff and hoped for a better and bright tomorrow to enlight the Homoeopathic System of Medicine. He read out the agenda points and stated that for today's meeting only 02 points agenda one for oath taking and another is election of President and Vice President NCH. He requested the house to precede further and requested Homoeopathic Doctor M.B. Jawed Awan to take Oath from the members being senior Member



of the House with the approval house. Homoeopathic Doctor M.B. Jawed Awan took oath from all 21 members of the Council.

- 4. Registrar presented next agenda point regarding election of President and Vice President of the Council and requested the house to present names who's interested to contest the election of President and Vice President National Council for Homoeopathy.
- 5. Homoeopathic Doctor Saeed ur Rehman Khattak proposed the name of Homoeopathic Doctor Mahmood ul Haq Abbasi as President which was seconded by Homoeopathic Doctor Muhammad Irfan Wali. He stated that while taking decision we should keep in mind that no decision should be taken against the principle of Homoeopathy, if it will be taken at any stage, he will strongly opposed that decision.
- 6. After having seat Homoeopathic Doctor Mahmood ul Haq Abbasi thanked all members of NCH to elect him as President unanimously and assured that he will work for promotion and up-gradation of Homoeopathic System of Medicine and will protect UAH Act, 1965 and Rules / Regulations framed there under. He will performed duties under the oath.



- 7. The chair requested the house to present name who desire to contest the election of Vice President. Homoeopathic Doctor Muhammad Moin Khan proposed the name Homoeopathic Doctor Rao Ghulam Murtaza for Vice President. Homoeopathic Doctor Waheed Ahmad seconded him. No other was interested to contest the election of Vice President. Homoeopathic Doctor Javed Akhtar also supported him.
