- 2. Meeting started at 11:30 AM. Homoeopathic Doctor Tabassum Hussain recited the verses from the "HOLY QURAN". Homoeopathic Doctor Siddique Ali Ansari offered Na'at Sharif. The President welcomed the all members. The meeting chaired by the President Homoeopathic Doctor Mahmood ul Haq Abbasi.
- 3. The House offered fateha/dua for late Homoeopathic Doctor Ch. Muhammad Ashraf, ex-member NCH, Homoeopathic Doctor Parvez Akhtar Qureshi, ex-President NCH and Homoeopathic Doctor Syed Munawar Ahmad Naqvi, President, Johar Homoeopathic Medical College, Khanpur and rest of all Homoeopathic Doctor who's died during the period of previous 6 months.

News

Agenda Point No. 1: To Confirm Minutes of previous 150th Regular Meeting of NCH held on 11-12 April 2019.

The President presented first point of Agenda before the House. The Registrar stated that no objection letter was received from any member except Homoeopathic Doctor Ilahi Bux, which was read out before the House. The President stated that objection of the honourable member is not correct because these points were actually discussed and decided in the previous meeting. Homoeopathic Doctor Ilahi Bux stated his view point, but not pressed further, therefore, the House unanimously confirmed the minutes of previous 150th (Regular) Meeting.

Agenda Item No. 2: To Confirm Minutes of Finance Committee Meeting held on 27th June 2019.

The President put up next agenda item before the House and invited Mr. Khalil Ahmed, Chairman Finance Committee NCH to brief the House. He read out the Minutes of the Finance Committee Meeting which was held yesterday i.e. 27th June 2019 before the house. The House unanimously confirmed the minutes of the meeting with some minor changes in heads of accounts.

Agenda item No. 3: To discuss and approved Budget Estimates for Financial Year 2019-29 and proposed Budget Estimates for the Financial Year 2020-21.

The President put up next agenda before the House with request to the Chairman Finance Committee to present the Budget Estimates for the FY 2019-20 and Proposed Budget Estimates for the FY 2020-21 before the House.

- 2. Mr. Khalil Ahmed, Chairman Finance Committee read out the Budget Estimates for the FY 2018-19 and proposed Budget Estimates for FY 2019-20, head-wise before the house. The Chairman Finance Committee pointed out that the current balance is insufficient and the estimated budget is excess than the current balance. The President said that in next FY expected income on account of DHMS Annual Examination 2019 will received with revise fee chairwhich may be approximately for 50 million. However, Council will meet the expenditure as allocated in the Budget and nothing is short fall in the Budget.
- During discussion the head of "Postage & telegraph" the allocated amount is very meager, the house resolved that a meeting may be scheduled with the authorities of GPO Rawalpindi for delivery of examinations documents (Question papers and Answer sheets etc) to Homoeopathic Medical Colleges in all over the country instead of COD basis through LCS. At this juncture, Homoeopathic Doctor Naeem Hafeez stated that complaints were received from H.M. Colleges regarding delivery of question papers on COD basis. He suggested to this practice may be stopped.
- 4. At the time of discussion the head of "Travel & Transportation of Govt. Servants & Others" the President referred Rule 4 of NCH (Administration and Financial Management) Rules, 2008 and stated that the President, Chairman or member are entitled to such privileges and travelling allowance are as admissible to the officers of equal status of the Federal Government. The house agreed to give all privileges to the members of the Council of equal

status of Govt. Officers of BPS-18-19. The House further constituted a committee comprising President and Chairman Finance Committee who will prepare a draft in this regard.

- 5. Homoeopathic Doctor Javed Akhter stated that students software has recently been introduced and may be adopted for the students of H.M. Colleges .
- 6. The chair stated that software specifications as prepared by the office may be circulated amongst the members of NCH.
- After detailed discussion, the house unanimously resolved as under:
 - a) Approved Revised Budget Estimates for the Financial Year 2018-19 and Budget Estimates for the Financial Year 2019-20 with the following addition / deletions:-
 - Restored heads of "Purchase of Land" and "Construction of building for University and allocated an amount of Rs. 1000/as token money in both heads.
 - ii) Grant-in-Aid to H.M. Colleges may be restored and request may be forwarded to the Federal Government through CFC and he will look into the matter personally.

At the end, the President thanked all Members and Chairman Finance Committee for their participation and cooperation and Staff of NCH for preparing Budget of the Council in a short time.

Agenda item no. 4: To Confirm Minutes of Inspection Committee meeting held on 27th June 2019

The President put up next agenda item regarding confirmation of minutes of Inspection Committee meeting held on 27th June 2019 at 2:00 PM. He invited the Chairman Inspection committee to brief the House about decision taken by the committee in yesterday's meeting. The Chairman Inspection Committee read out the minutes of the committee which were approved by the House. The House approved the same and resolved that the said minutes must be circulated amongst the members of the Council.

Agenda Item No. 5: To discuss and approve expenditure of Rs. 115,449/- regarding NCH Elections 2018 submitted by Revolution Media (Pvt.) Limited.

The chair presented next agenda item and stated that amount has already been discussed and approved by the Finance Committee in yesterday's meeting. As the amount was already approved by the Finance Committee, therefore the house also approved the expenditure of Rs. 115,449/- on account advertisement of NCH Elections 2018 through Revolution Media (Pvt) Limited.

Agenda Item No. 6: To discuss Explanation Letter to Controller of Examinations by the Ministry vide letter dated 7th May 2019.

The President put up next agenda item and stated the Assistant Director (Homoeo) M/o NHSR&C Islamabad called an explanation of Homoeopathic Doctor Muhammad Aamir Shafique, Controller of Examinations NCH on account of non-conduction of DHMS Supplementary Examinations 2018. He read out the Ministry's letter dated 07-05-2019 before the House. Homoeopathic Doctor M.B. Jawed Awan said that Ministry has no right to call directly explanation of Controller of Examinations. He required to write a letter to the Registrar NCH Homoeopathic Doctor Ilahi Bux stated that reply of Controller of Examinations with a covering letter of Registrar should be submitted to the Ministry. Homoeopathic Doctor Saeed ur Rehman Khattak said that reply should be forwarded to the Ministry in detail, which covers all aspect of the case.

DECISION:

The Council deplores the letter dated 07-05-2019 of Assistant Director (Homoeo), M/o NHSR&C to the Controller of Examinations directly without jurisdiction. However, the reply should be submitted to the Ministry as decided by the Council, to save the future of the thousands of students, Council allowing the previous Examining Body to take examinations of the students as per desire of the Federal Government. It was further directed to the Registrar and Controller of Examinations to take necessary steps in this regards.

Agenda Item No. 7: To discuss Ministry of NHSR&C letter No. F. 2-11/2016-Homoeo dated 20th May 2019 regarding constitution of Examining Body, NCH.

The President put up next agenda item, read out Ministry of NHSR&C letter No. F. 2-11/2016-Homoeo dated 20th May 2019 and briefed about the back ground of the case. He informed that the Examining Body has not yet been notified by the Ministry despite of repeated requests and reminders issued by the office. Homoeopathic Doctor Rao Ghulam Murtaza said that member at serial No 1 notified by the Federal Government, if he has served any show cause notice why the Ministry notified him as member of NCH and now why he cannot be notified as member of Examining Body. After some discussion, the Council reiterated its previous recommendations and decided that show cause notice is not a punishment because after issuance of show cause notices, the concerned persons were working as members of the Council as well as Examining Body of NCH till tendering of resignations. There is nothing in show cause after lapsed of 03 years is based on malafide. Therefore, send proper reply of above letter to the Ministry of NHSR&C.

- 2. Meeting started at 10:30 AM. Homoeopathic Doctor Tabassum Hussain recited the verses from the "HOLY QURAN". Homoeopathic Doctor M.B. Jawed Awan offered Na'at Sharif. The President welcomed the all members. The meeting chaired by the President Homoeopathic Doctor Mahmood ul Haq Abbasi. The chair welcomed the members in the meeting.

Point No. 8: To discuss Ministry of NHSR&C letter No. 1-10/2017-Homoeo dated 19th April 2019 and 14th May 2019 regarding issuance of Ultrasound Certificates and Use of Diagnostics Tools etc.

The President put up next agenda item. He read out the both letters of the Ministry of NHSR&C dated 19th April 2019 and 14th May 2019 before the house. The President directed Registrar to brief the house before start of the case to end. Registrar briefed the house in detail.

- 2. Homoeopathic Doctor Ilahi Bux questioned that is there any provision exist in the UAH Act, 1965 regarding grant any degree or diploma except diploma of DHMS. Whether all colleges were inspected properly before grant of permission of ultrasound classes and during the course of training? President read out section 24 and 47 of the Act before the house. He said that we are bound to follow the UAH Act, 1965 not PMDC Ordinance which is not applicable on the Council. Homoeopathic Doctor M.B. Jawed Awan said that clauses of PMDC Ordinance cannot be imposed on NCH. The Vice President read out Order of Punjab Mohtasib and SOP issued by the NCH in this regard.
- 3. Homoeopathic Doctor Muhammad Tariq Khan said that only deficiency on our part the syllabus of ultrasound training is not approved by the Federal Government under Section 47 of UAH Act, 1965. Homoeopathic Doctor Rao Ghulam Murtaza, Vice President proposed that reply may be submitted to the Ministry after consultation with the legal Advisor. Homoeopathic Doctor Ilahi Bux said that if it is possible that Council made reference in this regard and sent to the President of Pakistan for clarification of President's order. President NCH said that we should reply to the Ministry in detail alongwith all orders. Ministry may seek clarification, if desired from the President of Pakistan. Homoeopathic Doctor Ilahi Bux said that NCH reply and a copy of proposed syllabus of ultrasound must be circulated amongst the members before sent to the Ministry.

DECISION:

The House decided that a detailed reply, after consultation with the Legal Advisor may be sent to the Ministry. Syllabus of Ultrasound Training may also be circulated amongst the members of the Council

TABLE MOTION: RE-CONSTITUTION OF COMMITTEES OF NCH

With permission of the chair, Homoeopathic Doctor Ilahi Bux stated that committees of NCH have been re-structured. He handed over a list of ne proposed committee to the Chair. <u>The house resolved that it may be circulated amongst the members of the Council and will be discussed in next meeting in the light of progress by committees in previous year.</u>

TABLE MOTION: REGISTRATION OF PRACTITIONERS OF AJK COUNCIL

With permission of the chair, the Vice President Homoeopathic Doctor Rao Ghulam Murtaza briefed the House regarding assignment issued by the office vide letter dated 6th February 2019 and 30th April 2019 in the light of decision of the Council taken in 149th Regular Meeting held on 27-29 December 2018. He stated that the Council and College are situated in the same building. During visit it appeared that Council is divided in two portions one in Mirpur and another in Rawala Kot. Homoeopathic Doctor Muhammad Rafaqat Ch is President of AJK Council and also working as Principal of Homoeopathic Medical College. The Council is involved in admission of Arts students from Pakistan. During the session 2018-19 200 students were enrolled and seems 80% Arts students and 20% Science Group. He said that the House should frame a policy in this regard and it should also be published in newspaper through an advertisement. Homoeopathic Doctor M.B. Jawed Awan said that Kashmir Homoeopathic Council is a self adopted Council. If they admitted students in DHMS according to the provision of our Act, we should read to register them. Homoeopathic Doctor Javed Akhter suggested that representation of Kashmir Council may be called here for meeting and sought out the issue. He stated that the committee visited the AJK Council and recommended as under:-

- i) To visit Rawala Kot Campus of the Council
- ii) To call the representatives of both Councils for negotiation.
- iii) To publish advertisement in Newspapers.
- 2. Homoeopathic Doctor Ilahi Bux stated that we should publish that only those can practice in Pakistan who's registered with NCH Pakistan.
- 3. Homoeopathic Doctor Aisha Nawaz stated that we should take test of the students of AJK Council who desire to register with NCH Pakistan.
- 4. Homoeopathic Doctor Saeed ur Rehman Khattak stated that NCH Pakistan should publish public notice in newspaper regarding criteria of Registration and status of Homoeopathic Medical Colleges.
- 5. Mr. Khalil Ahmed, DS (Budget) said that law of Pakistan do not barred any student for study from anywhere inside or outside the country. AJK Council is required to adopt whole UAH Act with amendments made in the Act. He opposed to visit the Rawala Kot campus.
- 6. President said that Act of the AJK Council in their territory is lawful. However, Homoeopathic Doctor Muhammad Rafaqat Ch may be called in person in the capacity of registered practitioner as he has registered with NCH Pakistan.

DECISION:

The House resolved that clarification may be advertised in newspaper regarding admission under Section 21 of the Act and criteria of registration under Section 24 of the Act. The Committee already constituted will visit the Rawala Kot Campus and will submit its report to the office in writing before next meeting of the Council.

TABLE MOTION: MAGNETO THERAPY

With permission of the chair, Homoeopathic Doctor M.B. Jawed Awan presented and also read out the report of the committee on Magnet Therapy before the House. He said that the Council should design a course in this regard. Homoeopathic Doctor Naeem Hafeez said that who will train the people who desire to practice in the Magneto therapy. Only trained persons should be allowed to practice. Mr. Khalil Ahmad, DS (Budget) said that this therapy is not a permanent treatment of a disease, this is for only a time being relief. This therapy is not covered under UAH Act. This is a supporting tool. Homoeopathic Doctor Saeed ur Rehman Khattak said that this can be used additional tool, it is also mentioned in the syllabus of BHMS. He agreed with the report submitted by the committee. Homoeopathic Doctor Siddique Ali Ansari said that training period should be six months instead of one year. Homoeopathic Doctor Tabassum Hussain seconded him.

DECISION:

The House approved the report and resolved that the Council has NO objection on practicing magneto therapy by Registered Homoeopathic Practitioners as supporting tool. The duration of the course will be six months instead of one year. Thereafter, the syllabus may be forwarded to the Federal Government, after consulting the Syllabus Committee.
