

2. The meeting started at 11.00 a.m. Homoeopathic Doctor Tabassum Hussain recited verses from the "HOLY QURAN." Homoeopathic Doctor Siddique Ali Ansari offered Na'at Sharif. Meeting chaired by the President Homoeopathic Doctor Rao Ghulam Murtaza. He welcomed all the members for their participation in the meeting.

**Agenda Item No. 1: To confirm Minutes of previous 157<sup>th</sup> Annual (Budget)/Regular Meeting held from 17-19 June 2021.**

The Chair put up the first agenda item before the House regarding confirmation of minutes of the previous 157<sup>th</sup> Annual (Budget)/Regular Meeting held from 17-19 June 2021, which have already been circulated amongst the Council members. The Secretary informed the House that only two members namely Homoeopathic Doctor Ilahi Bux and Javed Akhter raised



their objections to the minutes. With permission of the chair, he read out objections before the House as under:-

**Agenda Item No. 2: To confirm Minutes of the Syllabus Committee Meeting held on 3<sup>rd</sup> November 2021.**

The Secretary/Registrar put up minutes of the Syllabus Committee Meeting held on 3<sup>rd</sup> November 2021 before the House, which have already been circulated amongst the members of the Council. He stated that no objection from any member has been received as yet. The House approved the minutes.



**Agenda Item No. 3: To confirm Minutes of the Finance Committee Meeting held on 23<sup>rd</sup> December 2021**

The Secretary/Registrar put-up of next agenda item regarding confirmation of minutes of Finance Committee Meeting held on 23<sup>rd</sup> December 2021 before the House. The Chair requested the Chairman Finance Committee to brief the House. The Chairman Finance Committee read out the minutes before the Council, which the House unanimously approved.

**Agenda Item No. 4: To confirm Minutes of the Inspection Committee Meeting held on 23<sup>rd</sup> December 2021**

The Secretary/Registrar put-up the next agenda item regarding confirmation of the minutes of the Inspection Committee Meeting held on 23<sup>rd</sup> December 2021, which was approved by the House with a vote of dissent by Homoeopathic Doctor Ilahi Bux.

**Agenda Item No. 5: To confirm Minutes of the Act, Rules & Regulations Committee Meeting held on 23<sup>rd</sup> December 2021**

The Secretary/Registrar put up next agenda item regarding confirmation of minutes of the Act, Rules & Regulations Committee Meeting held on 23<sup>rd</sup> December 2021 before the House. After some discussion, the Council approved the minutes unanimously.

**Agenda Item No. 6: To discuss Ministry of NHSR&C letter No. F. 1-18/2019- AD (Homoeo) dated 20<sup>th</sup> September 2021 regarding 06 (Six) Homoeopathic Medical Colleges.**

The Chair presented the next agenda point and directed Secretary to brief the House. The Secretary read out Ministry of NHSR&C letter No. 1-18/2019-Ad (Homoeo) dated 20<sup>th</sup> September 2021, which was circulated amongst the members of the Council, regarding the following 06 (Six) Homoeopathic Medical Colleges one by one:-

- i) Pakistan Homoeopathic Medical College, Lahore (Both DHMS & BHMS).
- ii) Dr. Hamid Memorial Homoeopathic Medical College Lahore
- iii) Attba Homoeopathic Medical College Jauharabad
- iv) Alavi Homoeopathic Medical College Karachi
- v) Al-Sehat Homoeopathic Medical College, 952, Ghulam Rasool Nagar, Faisalabad
- vi) Al-Sehat Homoeopathic Medical College P-13, Gulshan Colony, Faisalabad.

2. He further read-out NCH reply as forwarded to the Ministry vide letter No. NCH/F. 1-2 (PMDU)/2021-5406 dated 7<sup>th</sup> October 2021 and the Principals of Pakistan HMC Lahore and Al-Sehat HMC (Dr. Shakoor) Faisalabad vide letter dated 4<sup>th</sup> October 2021. After a detailed discussion, the House endorsed replies of the office submitted earlier to the Ministry.

**At 1:00 p.m. the House adjourned for Juma prayer and lunch break till 2:30 PM**



**Agenda Item No. 7: To Discuss matter relating to Show Cause Notice to Sughra Memorial HMC Karachi.**

The Chair put-up the next agenda item and directed the Secretary to brief the Council. The Secretary / Registrar informed that after approval of the Council in its previous meeting show cause notice was issued vide letter No. NCH/F. 9-73/1993-4645 dated 24<sup>th</sup> August 2021 to the Principal Sughra Memorial Homoeopathic Medical College Karachi. The letter was dispatched through UMS14226786 on 24<sup>th</sup> August 2021 but received back on 6<sup>th</sup> September 2021 with the remarks of the Postman that he visited the college on 26<sup>th</sup> August 2021, 27<sup>th</sup> August 2021, 28<sup>th</sup> August 2021, 30<sup>th</sup> August 2021 and 1<sup>st</sup> September 2021. Still the college found closed consecutively. The said letter was another time dispatched through UMS14226270 on 9<sup>th</sup> September 2021. Still, the Postman again informed that he visited the college on 11<sup>th</sup> September 2021, 12<sup>th</sup> September 2021, and 14<sup>th</sup> September 2021, but the college was found closed. He contacted on the telephone as mentioned on the envelope, but the phone was not responded. The Superintendent NCH contacted Mr. Shahid, Principal Sughra Memorial HMC Karachi, and informed the whole situation. Superintendent also sent a copy of the said show-cause notice to Mr. Shahid through WhatsApp, but as yet, after lapsed of 03 months, no reply of show cause notice has been received in the office of NCH. The Secretary further informed that another letter for inspection fee deposit was also sent but received back undelivered with the same remarks. Therefore, because of the situation as narrated above, it is established that the college is not working correctly.

2. At this juncture, the Chair asked for the enrolment and examination forms. The students of Sughra HMC Karachi are being entertained in the office of NCH or otherwise. The Secretary informed that enrolment and examination forms are being received regularly and accepted by the office accordingly.

**Decision:**

*After detailed discussion, it was resolved that one more chance may be given to the college and a copy of show-cause notice be re-dispatched through TCS or any other permissible mode of communication with direction to submit reply of show cause notice within a period of 15 days.*

**Agenda Item No. 8: To discuss matter relating to Show Cause Notice to Nishtar HMC Chiniot.**

The President put up the next agenda item regarding a matter relating to show cause notice of Nishtar HMC Chiniot. The Secretary stated that show-cause notice was issued to the college on 31<sup>st</sup> August 2021 and reply of show cause notice was received on 05-10-2021. He read out a reply of the Principal as follow:-



*"After receiving show cause notice, Nishtar Health and Education Society probed into the matter raised during exams of 2020. The origin of all issues was analyzed. Office Superintendent H/Dr Gias ur Rehman was found responsible for all the discrepancies, irregularities, ambiguities, misuse of power, misconduct and violation of rules. He was dismissed from the post on the very same day by the principal. Further action taken by the society to rectify the situation are as under:-*

- a) Principal Ashraf Zia on grounds of health issues is no longer the principal now, Rubina Kausar D/o. Bashir Ahmad is new Principal now.*
- b) Fresh and energetic teaching faculty has been appointed, list attached.*
- c) All new admin staff of the college has been recruited.*

*All these measures have been taken to improve the quality of education at the institution and maintain the standard of Homoeopathy. Exam 2021 has been conducted by new admin staff. Transparency during current exams is proof that we are striving hard. The institution needs one more chance to get rid of the allegations."*

2 Homoeopathic Doctor Faisal Saleem suggested that the Principal's reply may be considered after recovery of material i.e. Stamp of Controller of Examinations, self-generated roll number slips and unused answer scripts etc.

**Decision:**

*After detailed discussion, the House decided that the Principal Nishtar HMC Chiniot be directed to return Stamp of Controller of Examinations, self generated roll number slips of the students and unused answer scripts to NCH office at the earliest. Moreover, a report on recovered material is submitted before the Council in its next meeting.*

**Agenda Item No. 9 : To discuss Inspection Report of newly established Pir Mumtaz HMC Dera Ismail Khan.**

The Chair presented the next agenda item and directed Secretary to brief the house. He informed that an application for the establishment of a newly set-up namely Pir Mumtaz Homoeopathic Medical College Dera Ismail Khan on 02-06-2021. The Council constituted the Inspection team in its previous meeting, which inspected the proposed building on 9<sup>th</sup> October 2021. The Inspection Team believes that the college fulfills the requirements for recognition as per Regulations for Recognition of Homoeopathic Teaching Institutions, 1988, so the college is recommended for recognition.



2. Homoeopathic Doctor Ilahi Bux stated that in his information, another institution for Pharmacists Category "B" (60 seats) in 2 shifts is also running in the building, and premises is dedicated for the same purpose.

3. The Vice-President – Homoeopathic Doctor Saeed ur Rehman Khattak and Homoeopathic Doctor M.B. Jawed Awan clarified that building for Homoeopathic Medical College is separate and having sufficient covered area is available. The Pharmacy institution is running in another place / building. The House approved the inspection report of Pir-Mumtaz Homoeopathic Medical College, Dera Ismail Khan and advised Secretary / Registrar to forward the case to the Federal Government for recognition under relevant Section of the UAH Act II of 1965.

4. At this juncture, the President referred to Rule 9 (4) of UAH System of Medicines Rules, 1980, and requested the House to interpret the said rule. He stated that as per Rule "No institution shall be established in rented building" Still, there is no ban on establishing Homoeopathic institution in a donated or rental-free building. The Vice President seconded the view-point of the President and stated that if any person or member of the society donated the building to the society on court stamp paper duly notarized by the Oath Commissioner would be enough.

5. Homoeopathic Doctor Mahmood ul Haq Abbasi, Javed Akhter, and Mr. Khalil Ahmed took part in the discussion. Homoeopathic Doctor Ilahi Bux is of the view that buildings should be transferred to the name of the college and should be an asset to society. After discussion, the House allowed that a new Homoeopathic Medical College be established in a donated building on court stamp paper duly notarized by the Oath Commissioner. Homoeopathic Doctor Ilahi Bux and Javed Akhter recorded their vote of dissent.

6. *The House further resolved that the Federal Government be requested again for:-*

*a). Deletion of Rule 9 (4) of UAH System of Medicines Rules 1980 in the best interest of the Homoeopathic System of Medicine.*

*b) Permission to establish colleges in buildings obtained on long term rental leases by relaxing the conditions of building acquisition. And, or*

*c) Rental-less buildings surrendered by a member or office-bearer of the association for an indefinite period (not less than ten years).*



**Agenda Item No. 10 : To discuss Inquiry Report of Murree Homoeopathic Medical College Murree/Islamabad**

The President put up the next agenda item before the House and invited Homoeopathic Doctor Naeem Hafeez to brief the Council. He briefed and read-out the contents of the report and recommended that not to take action against the college, which meets all the requirements of relocation as per the then rules and procedure until and unless the college fails to deposit the required fee afresh within a week. However, after defacing it with the words "Cancelled", the mutilated monetary instrument be kept safely in the record of the Council. The Secretary also read out the Principal Murree HMCs letter No. 042-MR/21-22 dated 17-10-2021 before the House. Homoeopathic Doctor Javed Akhter suggested restoring the NOC subject to payment of fees of Rs. 50,000/- to NCH.

**Decision:-**

*After discussion, the House disagreed with the contents of the letter dated: 17-10-2021 by the Principal Murree HMC Murree/Islamabad and decided that NOC may be restored subject to deposit of change of building fee of Rs. 50,000/- in the shape of a Pay Order in favor of NCH within 15 days.*

**Agenda Item No. 11 : To discuss complaint and show cause notice to Homoeopathic Doctor Muhammad Arshad Saleem (Gujrat).**

The Chair informed the House that a complaint was received from Homoeopathic Doctor Ali Muhammad against Homoeopathic Doctor Muhammad Arshad Saleem (Gujrat), on 01-09-2021, regarding his illegal DHMS, registration and practice etc, which was also read out before the House. He further stated that on receipt of the complaint, Homoeopathic Doctor Muhammad Arshad Saleem was directed vide a letter dated 6<sup>th</sup> September 2021 and subsequent reminder dated 15<sup>th</sup> September 2021 and 29<sup>th</sup> September 2021 to provide copies of attested mark sheets, academic and professional certificates/degrees, appointment letter as lecturer, joining report etc within a week but he failed to do so. Therefore, due to non-receipt of requisite documents / reply within a specific period, he was served a show-cause notice on 8<sup>th</sup> October 2021 with the direction to submit your reply within 14 days of receipt of the notice. Thus no reply of show cause notice has been received so far, so he recommended for cancelling his registration and renewal certificates and removing his name from the register under Section 28 of the UAH Act II of 1965. However, Homoeopathic Doctor Javed Akhter was not agreed to the cancellation of registration and renewal of the practitioner.



Decision:-

*The House decided to cancel registration and renewal certificates and remove the name of Homoeopathic Doctor Muhammad Arshad Saleem (Gujrat) under Section 28 of the UAH Act, II of 1965. However, he has the right to file representation before the Council under the existing law.*

Agenda Item No. 12: To discuss letter dated 23-09-2021 received from Homoeopathic Doctor Sardar Muhammad Farooq Khan, Administrator Al-Islam Homoeopathic Medical College Rawalakot (AK) for permission of practice in Pakistan & Director General Health AJ&K letter dated 16-09-2021 regarding registration of Kashmir HMC Mirpur with NCH Pakistan.

The chair put up the next agenda item regarding registering practitioners qualified from AJK Council and recognition /affiliation of institutions with National Council for Homoeopathy Pakistan. He directed the Secretary to brief the House. The Secretary informed the House that two letters were received, one from Homoeopathic Doctor Sardar Muhammad Farooq Khan (Al-Islam Homoeopathic Medical College & Hospital Rawalakot (AJK) and another from the Kashmir Homoeopathic Medical College Mirpur (AJK) for the purpose. He stated that copies of both letters have already been circulated amongst the members of the Council with agenda. However, he again read out both letters before the house.

2. Homoeopathic Doctor Ilahi Bux invited the attention of the House towards Rule 4 (1-A) of U.A.H. System of Medicines Rules 1980, in this connection .....*Persons who obtain a degree or diploma in the Unani, Ayurvedic or Homoeopathic System of medicines as regular students from a recognized institution in the country or from abroad, duly verified by the Embassy of Pakistan in that country may apply for registration to the Registrar of the respective Council on prescribed form*".

3. Mr. Khalil Ahmad read out Section 24 (3) of the UAH Act 1965 and opposed AJK practitioner's registration/recognition of institutions with NCH Pakistan in the present scenario.

Decision:

*After discussion and considering all aspects of the matter, the Council up-hold the previous decision taken in its 156<sup>th</sup> Regular Meeting which has already been conveyed to the AJK Homoeopathic Council vide letter dated 9<sup>th</sup> September 2020.*

Agenda Item No. 13: To discuss matter relating to recognition of Shifa HMC Swat.

As discussed and decided at Agenda Item No. 9 (5) above.

**Agenda Item No. 14: To discuss approval of Map of the NCH Building Rawalpindi from RDA. (Rawalpindi Development Authority)**

With permission of the chair, Secretary informed the House that the Map of the NCH Building situated at Fazal Town (Phase-I) Airport Link Road Rawalpindi is not approved by the Rawalpindi Development Authority. The office contacted the concerned section of the RDA, and he informed that approximately 4.0 million (Rupees:- Forty lac only) will be incurred on the approval of the Map of the building through approved Architects for the year 2021 in RDA. He also provided approved Architect's List. The chair questioned that the inquiry of the existing building has been concluded by the FIA or otherwise. The Secretary replied that the inquiry is still pending at the FIA Islamabad. Mr. Khalil Ahmed, CFC, suggested to locating a building in Islamabad.

**Decision:**



*The House disagreed with the approval of the Map of the existing building by the RDA until the Inquiry conclusion by the FIA Islamabad.*

**Agenda Item No. 15: To discuss present status of NCH Building at Karachi.**

The chair presented the next agenda point and requested Homoeopathic Doctor Ilahi Bux to inform the House about assignment's progress. Homoeopathic Doctor Ilahi Bux stated that in compliance with the Council's decision in the previous meeting, the committee met with M/s Sindh Medical Store (SMS) at its office located at Shahrah-e-Faisal Karachi at 02.00 p.m. on 26<sup>th</sup> November 2021. The main objective of the meeting was to negotiate in the light of the circumstances following the dismissal of the FIRST RENT APEAL NO. 109/2020, by the court of District Judge Karachi East (Rent Appellate Jurisdiction). He presented and read the report on the meeting with Messer Sindh Medical Stores Karachi before the House.

2. Mr. Khalil Ahmed stated that the committee gives no new proposal in his report. The Ministry also recommended a new agreement in his report. He once again supported the new agreement with revised rent and terms & conditions. He opposed further litigation against SMS.
3. Homoeopathic Doctor Siddique Ali Ansari was not agreed to a new rental agreement for further 03 years in any way and assured the house that he would vacate the building from SMS.
4. The Vice President Homoeopathic Doctor Saeed ur Rehman Khattak proposed that the same committee will negotiate with SMS for a new rental agreement. The house may be constituted two members committee who will negotiate with SMS today.
5. Homoeopathic Doctor Mahmood ul Haq Abbasi disagreed with another agreement with SMS.
6. Homoeopathic Doctor M.B. Jawed Awan referred committee report, recommended a new rent agreement with the tenant and proposed to constitute a new committee comprising Chairman Finance Committee, Homoeopathic Doctor Ilahi Bux, and Registrar for the purpose.

**Decision:**

*After a detailed conversation, the House constituted a new committee comprising Chairman Finance Committee, Homoeopathic Doctor Ilahi Bux, and Registrar for finalization of the draft of new rent agreement after negotiation with SMS with the help of Legal Advisor and submit before the Council for final approval.*



**Agenda Item No. 16: To discuss requests of the Principals : Pakistan Central HMC, Sarban HMC, The HMC, Al-Sehat HMC, Kohsar HMC, Chakwal HMC, Danish HMC, Allied HMC, Jhelum HMC and Yasir Niaz HMC for restoration of their allocated seats.**

The President informed the House that applications of some Homoeopathic Medical Colleges had been received for restoration of allocated seats before the session 2019-20. However, principal of H.M. Colleges are requesting a one-time dispensation for admission of students for the current session as the entrance qualification has been enhanced from Matriculation to F.Sc. (Pre-medical), and a considerable number of candidates are visiting the colleges for admission in DHMS. *Therefore, after a detailed discussion and bearing in mind all the aspects, the Council decided that students shall be enrolled for the session 2021-22 in accordance with Rule 10 of UAH System of Medicine Rules, 1980 read with Regulation 21 (1-A) of the Homoeopathic Examinations Regulations 1986.*

**Agenda Item No. 17: To discuss letter dated 11-10-2021 of Homeopathic Doctor Ilahi Bux, Member NCH regarding teaching faculty of HMCs – Need of systemized listing.**

The chair put up the next agenda item and requested Homoeopathic Doctor Ilahi Bux to view on the issue.

2. Referring the Section 30 (3), 47 (f) of the UAH Act 1965 and Rule 2 (i) of the UAH Rules 1980, Homoeopathic Doctor Ilahi Bux stated that there is no formal Register of eligible teachers to make or secure entries under Rule 2 (i) of the UAH Rules, 1980. List of Teachers received on the Form-V (annexed with the above referred Rules) without supporting documents and scrutiny is supposed to be perfect and uploaded to the NCH. Hence, it pertains to so many errors and deficiencies so far. A random going-over of Form-V of few colleges reveals as follow:-

**A. GENERAL INADEQUACIES**

- (i) Date of submission of the Record is not available.
- (ii) Incomplete and incorrect entries.
- (iii) It seems to be used as a voter list for teachers of HMC as required under Section 5 (c) of UAH Act 1965 read Rule 2 (i) and 17 (e) of UAH System of Medicines Rules, 1980. Frankly, a fair election is not possible in these circumstances.
- (iv) Entries are incorrect were not crossed checked by the NCH office.
- (v) List of teachers show Part-time teachers alongside Full timer. The question stands whether the part-time teacher is eligible to be a valid voter.

**B. FEW PARTICULAR INADEQUACIES IN FOLLOWING HMCS**

- i) Pakistan HMC Lahore
- ii) Al-Shams HMC Chishtian.
- iii) Foundation HMC Hyderabad.
- iv) Alavi HMC Karachi



- v) Khushal Khan Khattak HMC Peshawar
- vi) Nusrat HMC Quetta

2. The focal point of the issue is that every appointment for teaching faculty should be systemized.

**Decision:**

*The House resolved that the office should obtain a new list of teaching staff on form-V from all Homoeopathic Medical Colleges and regularly maintain with addition and deletion.*

**Agenda Item No. 18 : To discuss complaint against Homoeopathic Doctor Ali Muhammad filed by Homoeopathic Doctor Ilahi Bux, Member NCH.**

The President put up the next agenda item and invited Homoeopathic Doctor Ilahi Bux to brief on the issue.

2. He stated that Homoeopathic Doctor Ali Muhammad is violating the UAH Act II of 1965 and its subordinate documents. A few of the concerns are as follows:-

- a) His academic qualification is Matric, and he was eligible to acquire DHMS. Therefore, he has got the same and enjoyed its perquisites and privileges accordingly.
- b) He has been registered as BHMS under Registration No 334, despite ineligibility because the place where he has been entered is only for full-length BHMS. In addition, it is noted that it possessed a thrown over Two-year BHMS-Graded Course., which may be an additional qualification in its highly efficient state. The continuity of his valid registration as DHMS is questionable and requires inquiry. He is anticipated to practice as a Homeopathic Doctor without any break. Hence, he may also be asked for Renewal Fee alongwith a fine as admissible under Rules. Moreover, it requires action in the light of Rule 4 (5) of UAH Rules, 1980.
- c) He is making himself believe with glossy advertising contents and appearance, canvassing, tall claims about treatment of specific diseases in his videos, and textual contents available on Facebook and other sites. His name has been illegally entered in the Register of BHMS 3-4 months ago, while he has been claiming himself DHMS and BHMS since long before and creating a false public impression. In addition he is using the word "Dr." as the prefix of his name, which is a violation of Section 39 (2) of the UAH Act 1965.

3. In the light of facts, it is requested that the name of Mr. Ali Muhammad be deleted from the Register administered for the five years BHMS. He may also be asked for a renewal of his DHMS Registration, and if he is willing, then as per Rules he may be allowed subject to the



dues. He may be directed that the additional qualification be displayed with prominence, namely "BHMS- Graded" after his actual relevant stuff, i.e. "DHMS".

4. The President stated that two years BHMS Degree Program was started twenty three years ago by Frontier Homoeopathic Medical College Peshawar and Khyber Medical University is awarding BHMS Degree to the students. Still students were not taking registration from NCH. As per the decision of the Council, concerned Universities and Homoeopathic Medical Colleges were directed through a letter to stop Two-years BHMS Degree Program and begin Five years Degree Program in the light of Rule 9 (a) of UAH Rules, 1980. Higher Education Commission Islamabad was also requested in this regard.

5. The Secretary also replied to the questions of Homoeopathic Doctor Ilahi Bux and assured that BHMS Register serial No. 1 to end shall be checked and updated. He further stated that no student is being registered who has passed his 2-year BHMS examination after 27-12-2018 (date of the decision of the Council).

**Decision:**

*After discussion, the House constituted following committee for formulation of a policy for registration of students who have passed BHMS Graded Degree Program Two-Years:-*

- 1) *Homoeopathic Doctor Saeed ur Rehman Khattak, Vice President*
- 2) *Homoeopathic Doctor Javed Akhter*
- 3) *Homoeopathic Doctor Faisal Saleem*

**Agenda Item No. 19: To discuss letter dated 28-06-2021 of Homoeopathic Doctor Ilahi Bux regarding Registration of Medical Practitioners as Homoeopaths – Policy & Scope of Two, unlike professions.**

*The chair resolved that the matter has already been discussed in previous meeting and up-hold decision as earlier taken by the Council.*

**Agenda Item No. 20: To discuss and approved draft of public circular/advertisement in the wake of the decision on agenda item No. 9 of 157<sup>th</sup> NCH Meeting received from the committee.**

With permission of the chair, the Secretary presented a draft of public / advertisement in wake of the decision on agenda Item No 9 of 157<sup>th</sup> NCH Meeting received from the committee on 2<sup>nd</sup> August 2021. *After an argument on the issue, the House decided that the said Public Circular /advertisement be uploaded on the NCH website instead of publication in the print media.*



**Agenda Item No. 21: To discuss letter dated 15-08-2021 of Homoeopathic Doctor Ilahi Bux, Member NCH – Misrepresentation – the case of Rehabilitation Centre.**

The chair presented the next agenda item and invited Homoeopathic Doctor Ilahi Bux to present the case.

2. Homoeopathic Doctor Ilahi Bux stated that Homoeopathic Doctor Farrukh Rashid is running a Prosthetic Rehabilitation Centre (Khalid Rehabilitation Centre Faisalabad) and practicing as a “Prosthetist” in the gear of a homoeopathic practitioner, which is beyond the legal and procedural limits provided by UAH Act 1965 and its subordinate legislation. Hence, the NOC issued by NCH to the said Homoeopathic Doctor is illegal. The information narrated intentionally or otherwise in the NCH meetings was improper led to upholding the decision even though the legitimacy of the issue was repeatedly questioned, In this regard, he presented some images of screenshots of the FB Page of Khalid Rehabilitation centre. He further stated that the applicant’s workshop was sealed by the Punjab Healthcare Commission and conditionally de-sealed. The circumstances transpire that the inspecting team has misguided the Council or has been misguided to provide a cover to the PHCs accused quack. The failure of a regulatory body to act within the scope of its enabling legislation invalidates its decision. He (Homoeopathic Doctor Ilahi Bux) requested that the matter may please be re-inquired, and the illegal permission issued by NCH earlier may please be withdrawn. Moreover, the Punjab Health Care Commission may be intimated accordingly.

3. Homoeopathic Doctor Faisal Saleem, Homoeopathic Doctor Naeem Hafeez, and Homoeopathic Doctor Mahmood ul Haq Abbasi took part in the discussion and gave their view-point.

4. The chair offered Homoeopathic Doctor Ilahi Bux to inspect the clinic, but he refused that he was mover and not interested to do so.

**Decision:**

*The House up-hold the earlier decision in this regard.*

**Agenda Item No. 22: To discuss reservation regarding Annual Inspection Schedule of H.M. Colleges received from Homoeopathic Doctor Ilahi Bux, Homoeopathic Doctor M.B. Jawed Awan and Homoeopathic Doctor Javed Akhter.**

The chair presented the next agenda item and directed Secretary to read out letters received from three members regarding the annual inspection of H.M. Colleges before the House. The Secretary did accordingly. After discussion, the chair resolved to provide a copy of the complete Annual Inspection Schedule to all members for their examination.



**Agenda Item No. 23: To discuss and approve resignation of Homoeopathic Doctor Ilahi Bux from Syllabus Committee NCH.**

The chair presented the resignation of Homoeopathic Doctor Ilahi Bux from the Syllabus Committee before the House, which the House rejected. *The House further appreciated the efforts for up-gradation of the Homoeopathic profession of Homoeopathic Doctor Ilahi Bux and requested him to withdraw his resignation.*

**Agenda Item No. 24: To discuss Inspection Report of Balochistan HMC Quetta**

With permission of the chair, the Secretary read out the inspection report dated 10<sup>th</sup> December 2021 conducted by the Inspectors of NCH on 21-10-2021. The Secretary informed the House that the present building of the college does not fulfill the requirement of Regulations for Recognition of Homoeopathic Teachings Institutions 1988. Therefore, the present circumstances, the standards of efficiency and education for students cannot be deemed secure. *After discussion, the House approved the inspection report. It <sup>was</sup> resolved to direct the college management to arrange a suitable building as per Yard Stick and remove other deficiencies / discrepancies within the next three (03) months positively.*

**Agenda Item No. 25: To discuss Inspection Report of Shah Abdul Latif Bhittai HMC Karachi**

With permission of the chair, the Secretary read out inspection report dated 03-12-2021 of Shah Abdul Latif Bhittai Homoeopathic Medical College Karachi conducted by Homoeopathic Doctor Siddique Ali Ansari, Homoeopathic Doctor Muhammad Moin Khan, and Homoeopathic Doctor Muhammad Idrees Tareen, Members of NCH before the House. The committee, in his report, observed that the college building is up to the yardstick but college administration should take a keen interest in proper maintenance of college building, renewal of the society certificate and maintain all account and related registers. *The house approved the inspection report and further resolved to direct the management of Shah Abdul Latif Bhittai HMC Karachi to remove the deficiencies / discrepancies within 30 days positively. Accordingly the earlier decision of the college regarding de-recognition of the college is withdrawn.*

**Agenda Item No. 26: To discuss Inspection Report of Dr. Noor HMC Multan**

With permission of the chair, the Secretary put-up the next agenda item and read out inspection report dated 21-12-2021 of Dr.Noor HMC Multan before the House. *The house unanimously approved the inspection report of the college.*

**Agenda Item No. 27 :To discuss Inquiry Report in case of Mr. Muhammad Hashim, show cause notice and its reply.**

Deferred for next meeting.



**Agenda Item No. 28. To discuss Inquiry Report in case of Aqleem Feroz, show cause notice and its reply**

Deferred for next meeting.

**TABLE MOTION : HOMOEOPATHIC DOCTOR ILAHI BUX**

With permission of the Chair, Homoeopathic Doctor Ilahi Bux draws attention to the decades-old issue that requires to be resolved. He pointed out the service status of the existing Registrar of the Council, namely Mr. Aamir Nadeem Ramay.

2. He further added that despite his outstanding performance, efficiency, competency, and disciplined attitude, he has ever been facing an awkward situation due to a minor administrative lacuna. "Respected President, Job in the public sector is deemed to be the most secured and suitable career for every citizen. Therefore, the object of recruitment to any regular post is to secure the suitable person who answers the demands of the job requirement" Nevertheless, in the



case of Mr. Aamir Nadeem Ramay, the matter becomes an unfinished conflict. He also added that regularization is applied when persons work for an extended period of more than a decade.

3. The House can play a vital role in resolving issues hindering crystallizing his job status through notifying him as Registrar by the competent authority. Prima facio, there is nothing illegal to determine that he may be considered a full-fledged Registrar and be notified accordingly.

#### DECISION:

*The House unanimously approves and appreciates the services rendered by Mr. Aamir Nadeem Ramay as Registrar since 24-11-2014 who is vigilantly pursuing the tasks given by the Ministry of NHR&C and NCH. Any defect in formal issuance of letter on the part of Ministry may be condoned.*
